Justice Center Repairs-Hurricane Ida

Scope: As a result of Hurricane Ida, the Justice Center encountered damages to the capstone on the northeast corner of the roof approximately 50 feet up. The damaged capstone, which measures approximately 3-feet-wide by 2-feet-high, needs to be removed and replaced. Additionally, the adjacent area to the damaged capstone needs to be inspected for any defects and repaired as required. This may include roofing material that is damaged during the process. The HVAC system was also damaged by electrical surges during Hurricane Ida. This was repaired at the cost of \$19,000. \$7,200 is being budgeted for the purchase of a surge protector for the HVAC system to mitigate future damages.

Status: The timeline for completing this project will be December 2023.
