Crisis Response Throw Phone

Acquire a throw phone to be used by negotiators assigned to the STP Sheriff's Office Special Weapons and Tactics (SWAT) team to allow negotiators to communicate directly with a subject/suspect during crisis situations, such as hostage and barricade situations, while providing covert video of the subject/suspect and their surroundings.

Acquire generators to ensure emergency power during an emergency response when an agency, facility, or equipment needs standby power until other emergency power can be supplied through contracting or requests to outside agencies, which could take a considerable time to
