ORDINANCE TO AMEND THE 2023 OPERATING BUDGET- 502  
UTILITIES OPERATIONS FUND.

WHEREAS, by Ordinance No. 7057 of 2022, an amendment to the Utilities Operations Fund (Fund 502) was passed to increase that Fund by three hundred and fifty thousand dollars (\$350,000.00); and

WHEREAS, the stated purpose for said increase was to provide funding to hire a company to assist in utility operations; and

WHEREAS, the funds have not been utilized and the Administration indicated an intent to utilize the funds for studies; and

WHEREAS, the Parish Council budgeted these funds for a contract to assist with utility operations, the Administration expressed an intent to use the funds for another purpose, and, to date, the funds have not been expended or encumbered, therefore, evidencing the fact that the funding will not be used for the intended purpose stated in the 2022 budget amendment.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS that in accordance with the above and foregoing, the 2023 Operating Budget – 502- Utilities Operations Fund is and is hereby reduced by three hundred and fifty thousand dollars (\$350,000.00), funding to be returned to the originating Fund.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective immediately upon final adoption.
