Safe Haven Pavilions-Hurricane Ida

Scope: Hurricane Ida caused damage to the Safe Haven Rotary Pavilion and Building A Gazebo. As a result, repairs are needed to restore roofing and structures.

Status: FEMA has obligated funding with a 10% cost share. Work anticipated to begin August 2023, and will take approximately 60 days to complete.
