EMERGENCY ORDINANCE TO AMEND THE 2024 CAPITAL IMPROVEMENT BUDGET AND CAPITAL ASSETS - AMENDMENT NO. 41
UTILITIES CAPITAL PROJECTS

WHEREAS, St. Tammany Parish has prepared a capital improvement budget and capital asset list in accordance with the Home Rule Charter.

WHEREAS, the Parish has identified additional capital improvements, capital assets, and/or grant-funded improvements for Fiscal Year 2024.

WHEREAS, this amendment is emergent, due to the nature to ARPA and Water Sector deadlines.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS that the 2024 Capital Improvement Budget and Capital Assets List is amended as follows:

AMENDMENT NO. 41 - 2024 CAPITAL IMPROVEMENTS - NOVEMBER 2024

SECTION I: CAPITAL IMPROVEMENTS - INFRASTRUCTURE (ROADS, BRIDGES, DRAINAGE, AND UTILITIES)

East Slidell Water Consolidation, Ph.1 - Cross Gates Water Well and Tower #2

Scope: Design and construction of a new Water Tower, Water Well, and Water Treatment Building including SCADA/telemetry and a generator at the Ozone Pines project site to provide increased capacity and resiliency.

This project requires additional funding in order to complete the scope of work. The original project construction estimates were completed in 2020 when the initial Water Sector application was submitted and the construction and material costs have increased significantly since the project was initially approved. These projects have been value engineered as much as possible from the original scope and design to still meet the requirements and minimize costs.

Status: Water Tower and Water Well have been bid out and are under construction. Request for additional funding is to complete construction of Water Treatment Building.

East Slidell Water Consolidation, Ph.2 - River Oaks Elevated Water Tank

Scope: Construct a new elevated water storage tank at the River Oaks Water Well site. Improvements and modifications to the water well will be completed as part of the project.

This project requires additional funding in order to complete the scope of work. The original project construction estimates were completed in 2021 when the Water Sector application was submitted and the construction and material costs have increased significantly since the project was initially approved. These projects have been value engineered to conform to the original scope and design requirements as close as possible but also minimize costs.

Status: The water tower has been bid out and is currently under construction. Request for additional funding is to complete construction of the Water Treatment Building and water well improvements.

Status: This project has been bid for construction and bids came in over budget. Request for additional funding is to fully fund the project in order to move forward with construction and execute the contract with the contractor.
