

WHEREAS, St. Tammany Parish Government has made application for certain grant funds made available and administered by the Louisiana Watershed Initiative; and

WHEREAS, pursuant to the grant program, St. Tammany Parish Government is required to purchase certain immovable property from approved applicants; and

WHEREAS, attached as Exhibit "A" is a list and/or location of the immovable property to be acquired pursuant to this grant program (collectively, the "Property"); and

WHEREAS, Parish desires to acquire the Property and authorize the Office of the Parish President to do whatever is necessary to enter into negotiations and acquire said Property.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that the Parish of St. Tammany, through the Office of the Parish President, is authorized to acquire by purchase, donation or otherwise, all or parts of the proposed parcels described on Exhibit 'A" attached hereto (collectively, the "Property"); and

BE IT FURTHER ORDAINED: that the Office of the Parish President is authorized to exercise its discretion in acquiring the Property, together with all agreements and all transactions necessary to carry out the intent of this Ordinance; and

BE IT FURTHER ORDAINED: that, if purchased, the purchase price shall not exceed the fair market value of the Property, plus closing costs and fees; and

BE IT FURTHER ORDAINED: that any and all actions previously taken by the Office of the Parish President in furtherance of the actions contemplated herein are ratified and accepted accordingly.

REPEAL: All Ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

# AMENDED COOPERATIVE ENDEAVOR AGREEMENT BY AND BETWEEN THE ST. TAMMANY PARJSH GOVERNMENT AND THE CITY OF COVINGTON (STP Buyout Program)

This Amended Cooperative Endeavor Agreement ("Amended Agreement") is made and entered into on the dates set forth herein below, pursuant to the 1974 Louisiana Constitution Article VII Section 14(C) wherein governmental entities are empowered to enter into Cooperative Endeavor Agreements, by and among the following parties:

- **ST. TAMMANY PARISH GOVERNMENT,** a political subdivision of the State of Louisiana and the governing authority of St. Tammany Parish, whose mailing address is P.O. Box 628, Covington, Louisiana 70434, herein appearing by and through Michael B. Cooper, Parish President, duly authorized (hereinafter referred to as **"Parish")**; and
- **THE CITY OF COVINGTON**, a political subdivision of the State of Louisiana, whose mailing address is P.O. Box 778, Covington, Louisiana 70433, represented by and through Mark R. Johnson, Mayor, duly authorized (hereinafter referred to as "City").
- **WHEREAS,** Parish is sub-grantee of funds, granted to the State of Louisiana, under the Community Development Block Grant Disaster Recovery and Mitigation/Resiliency Program (the "Program"); and
- **WHEREAS**, certain properties within the corporate limits of City are eligible for the Program; and
- **WHEREAS**, under the Program, Parish was originally awarded Program funding for buyout of seven parcels within the City's corporate limits; and
- **WHEREAS,** Parish and City entered into a Cooperative Endeavor Agreement to address the rights and responsibilities of administration of the Program within City's corporate limits in March, 2023; and,
- **WHERAS,** sufficient funds have become available since the execution of the 2023 Cooperative Endeavor Agreement to add four properties to the Agreement.
- **NOW, THEREFORE,** in consideration of the mutual benefits and covenants contained in this Amended Agreement, the Parties do hereby amend Paragraph 2. Section 2.2 of the March 2023 Agreement as follows:

#### 2. OBLIGATIONS OF CITY

- 2.2 City has selected the following properties to be considered for mitigation pursuant to the Program, for Parish's use with implementing the Program (collectively, the "Properties"):
  - 2.2.1 103 South Buchanan
  - 2.2.2 105 South Buchanan
  - 2.2.3 1107 Schech Dr.
  - 2.2.4 1109 Schech Dr.
  - 2.2.5 1113 Schech Dr.
  - 2.2.6 1115 Schech Dr.
  - 2.2.7 Lot 5, Square 2011, Division of New Covington Subdivision
  - 2.2.8 Lot 6, Square 2011, Division of New Covington Subdivision
  - 2.2.9 Lot 7, Square 2011, Division of New Covington Subdivision
  - 2.2.10 Lot 8, Square 2011, Division of New Covington Subdivision
  - 2.2.11 Lot 9, Square 2011, Division of New Covington Subdivision
