#### Federal Program Management, Ph.2

Scope: The Coastal Storm and Flood Risk Management (CSFRM) contract is a timely and necessary investment in programmatic readiness. It empowers St. Tammany Parish to effectively partner with USACE and CPRA, protect its communities, and advance a generational flood protection project that will safeguard lives, property, and economic stability for decades to come.

Status: To advance and support implementation of this monumental effort, St. Tammany Parish seeks to amend its existing contract to enhance its support under the task of program management.

## Materials of Opportunity

Scope: With a population of over 260,000 and estimates indicating continued growth throughout the Parish, development/redevelopment and infrastructure improvements will provide significant opportunities for product acquisition. These materials can then be further integrated into Parish projects.

St. Tammany Parish Government has an opportunity to develop a "Materials of Opportunity" program that would seek to best re-utilize/repurpose various materials, which would otherwise traditionally be discarded or underutilized, for programs or projects throughout the St. Tammany Parish (Materials include but are not limited to: Concrete, Repurposed Glass & Christmas Trees). Each year approximately \$500,000 is made available to St Tammany. Since this was initiated, two additional deposits were made.

## Tchefuncte Habitat Restoration

Scope: This critical infrastructure project aims to include construction of a breakwater system along the vulnerable shoreline of the Lake Pontchartrain Basin. The installation will serve as a frontline defense against escalating coastal erosion and storm surge, ensuring the long-term protection of unique wetland habitats, and safeguarding the Town of Madisonville and Western St. Tammany Parish.

Status: There are currently multiple phases related to this project. This project will go along with the Tchefuncte Habitat Restoration to the Lighthouse and the St. Tammany Artificial Reef project. Together, these projects form a cohesive coastal defense system, preserving habitat, protecting infrastructure, and enriching community life.

The anticipated construction time is Fall 2025 through March of 2028, respectively.
