ORDINANCE AUTHORIZING THE PARISH OF ST. TAMMANY, THROUGH THE OFFICE OF THE PARISH PRESIDENT, TO ACQUIRE STATE ROUTE LA 1129 (LEE ROAD) FROM THE STATE OF LOUISIANA, DEPARTMENT OF TRANSPORTATION AND DEVELOPMENT. (WARD 2, DISTRICTS 2 & 6)

WHEREAS, pursuant to Resolution Council Series No. C-6232 and a Cooperative Endeavor Agreement dated June 25, 2020, St. Tammany Parish Government agreed to accept ownership of whatever rights the State of Louisiana, Department of Transportation and Development may own in State Route La 1129 (Lee Road) in its entirety from its southern junction with State Route La 40 proceeding north approximately 5.368 miles to its junction with the local road known as La Tung Road; and

WHEREAS, Parish desires to acquire State Route La 1129 (Lee Road) and authorizes the Office of the Parish President to do whatever is necessary to enter into negotiations and acquire Lee Road from the State of Louisiana, Department of Transportation and Development.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that the Parish of St. Tammany, through the Office of the Parish President, is authorized to acquire by Act of Transfer and Acceptance from the State of Louisiana, Department of Transportation and Development, State Route La 1129 (Lee Road) in its entirety from its southern junction with State Route La 40 proceeding north approximately 5.368 miles to its junction with the local road known as La Tung Road.

BE IT FURTHER ORDAINED: that any and all actions previously taken by the Office of the Parish President in furtherance of the actions contemplated herein are ratified and accepted accordingly.

REPEAL: All Ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.
