ORDINANCE AUTHORIZING THE PARISH OF ST. TAMMANY, THROUGH THE OFFICE OF THE PARISH PRESIDENT, TO ENTER INTO A SERVITUDE AGREEMENT WITH ENTERGY FOR A SERVITUDE CROSSING STONEHILL ROAD (WARD 2, DISTRICT 3)

WHEREAS, Entergy is seeking to place one or more overhead lines for electrical transmission and/or service across property being identified as approximately 1.03 acres, more or less, in Section 32, Township 7 South, Range 10 East, which as adjudicated to Parish for non-payment of ad valorem taxes for year 2012 (Assessment #130445); and

WHEREAS, in anticipation of improvements to the provision of electrical transmission and/or service in the area, St. Tammany Parish desires to provide a servitude to Entergy and/or its affiliated entities across the subject property.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that St. Tammany Parish the Office of the Parish President is authorized to enter into a Servitude Agreement with Entergy and/or affiliated entities for that certain property identified as approximately 1.03 acres, more or less, in Section 32, Township 7 South, Range 10 East, which as adjudicated to Parish for non-payment of ad valorem taxes for year 2012 (Assessment #130445).

BE IT FURTHER ORDAINED: that the Office of the Parish President is authorized to exercise its discretion in granting a servitude on the property, together with all agreements and all transactions necessary to carry out the intent of this Ordinance.

BE IT FURTHER ORDAINED: that all actions previously taken by the Office of the Parish President to grant a servitude on the property are ratified and accepted accordingly.

REPEAL: All Ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.
