ADMINISTRATIVE COMMENT AMENDMENT NO. 33 - 2024 CAPITAL IMPROVEMENTS - SEPTEMBER 2024

SECTION I: CAPITAL IMPROVEMENTS - INFRASTRUCTURE (ROADS, BRIDGES, DRAINAGE, AND UTILITIES)

US11 Corridor (I-12 to North Blvd.)

Scope: Several years ago, LADOTD completed a study on the US11 corridor from I-12 to Gause Blvd. The study identified multiple improvements, but a priority was put on replacing the railroad bridge. While the bridge is needed, it does nothing to improve the lack of a protected left turn for constituents exiting the Ben Thomas area. This project will be to update the previous study completed by the LADOTD, as well as, look at the possibility of adding a protected left turn at the existing Powell Dr. or Ben Thomas Rd., or by adding a new connection at North Blvd.

Status: This budget request is to secure funding for the corridor study.
