Munis Reboot

Scope: This project will enable efficient use of the tool by all departments of government, enable ease of use within the system, enable transparency, and enable a fast and easy budgeting process for the future. By ensuring that we are a “standard” Munis deployment, we will have access to complete support by Tyler Technologies. The Munis reboot will be a standard deployment with the number of funds limited to the minimum number possible. The Department of Technology will be supervising the reboot. Maximum customization systemwide will be 20%.
