ORDINANCE TO REAPPORTION THE ST. TAMMANY PARISH COUNCIL DISTRICTS, AND TO DESCRIBE THE PRECINCTS THAT CONSTITUTE THE REVISED DISTRICTS, TO UPDATE, CORRECT, AND CLARIFY PRECINCT DESCRIPTIONS IN THE ST. TAMMANY PARISH CODE OF ORDINANCES, AND FOR RELATED PURPOSES.

WHEREAS, La. R.S. 33:1411 and Section 2-02 of the St. Tammany Parish Home Rule Charter mandate the parish council to examine the apportionment plan of the council after each decennial census, and to provide for a new apportionment plan if substantial variation exists in the representation of the election districts; and

WHEREAS, by resolution adopted on February 3, 2022, the parish council determined that reapportionment, also known as redistricting, is necessary based on the significant growth of the parish, as reflected in the 2020 decennial census, and based on the substantial variation in population among the council districts; and

WHEREAS, voting precincts are the building blocks of council districts. An examination of the precinct descriptions in Code of Ordinances Section 2-39 reveals that the descriptions have been subject to numerous changes over several decades, and that the descriptions need to be updated, corrected, and clarified to facilitate the redistricting effort; and

WHEREAS, the parish has procured legal, demographic, and mapping services to assist the parish council in developing a redistricting plan; and

WHEREAS, a redistricting plan, designated as Plan 5-D, has been recommended to the parish council for consideration and adoption, which Plan 5-D is attached hereto; and

WHEREAS, the redistricting plan should be enacted in sufficient time for the voters of the parish and prospective candidates for election to the council to understand the boundaries of the council districts, and should be effective for the fall of 2023 election cycle; now therefore

THE PARISH OF ST. TAMMANY HEREBY ORDAINS that Section 2-38 "Precincts" of the St. Tammany Parish Code of Ordinances is hereby amended to read as follows:

Sec. 2-38. Precincts

The parish hereby ordains that it confirms and re-establishes the parish Code of Ordinances, Article II, Wards, Precincts and Districts, to provide for voting precincts in conjunction with redistricting and in accordance with the ~~2010~~ 2020 Federal Decennial Census; and as reflected by the precinct numbers and descriptions in the sections of this article.

BE IT FURTHER ORDAINED that the Section 2-39 "Precinct Descriptions" of the St. Tammany Parish Code of Ordinances is hereby repealed.

BE IT FURTHER ORDAINED that the following Section 2-39 of the St. Tammany Parish Code of Ordinances is hereby enacted to replace section repealed in the foregoing paragraph:

Sec. 2-39. Precinct Descriptions

Precinct A01. Commence at the intersection of United Church Rd. and Lowe Davis Rd., also the point of beginning; thence follow Lowe Davis Rd. northeast to its intersection with Range Line Rd.; thence follow Range Line Rd. for approximately 80 feet to the continuation of Lowe Davis Rd.; thence follow Lowe Davis Rd. northeast and east to its intersection with Allen Rd.; thence follow Allen Rd. south and southwest to its intersection with Hwy. 435 (Talisheek Hwy.); thence follow Hwy. 435 (Talisheek Hwy.) south, southwest to its intersection with Level St.; thence follow Level St. continuing west to its intersection with La. 36; thence follow Hwy. 36 north, northeast, and west to its intersection with Dahlia St.; thence follow Dahlia St. north to its intersection with Progress St.; thence follow Progress St. west to its intersection with Rose St.; thence follow Rose St. north to its intersection with Emancipation St.; thence follow Emancipation St. west to its intersection with United Church Rd.; thence follow United Church Rd. north to its intersection with Lowe Davis Rd., also the point of beginning.

Precinct A02. Commence at the intersection of the Abita River and Hwy. 59; thence follow Hwy. 59 north into the Town of Abita Springs to its intersection with Level St.; thence follow Level St. east becoming Burvant St.; thence follow Burvant St. continuing east, then northeast and east to its intersection with Polaris St.; thence follow Polaris St. south and east to its intersection with Landry Ln.; thence follow Landry Ln. south, east, and south to its intersection with a branch of the Abita River; thence follow the branch of the Abita River west and northwest to its intersection with an unnamed road leading to Hwy. 36; thence follow the unnamed road southwest, southeast, and southwest to its intersection with Hwy. 36 (Hickory Hwy.); thence follow Hwy. 36 (Hickory Hwy.) northwest to its intersection with the southern branch of the Abita River; thence follow the southern branch of the Abita River southwest, west, and northwest to its intersection with Hwy. 59, also the point of beginning.

Precinct A02A. Commence at the intersection of Hoffman Rd. and Hwy. 59, also the point of beginning; thence follow Hwy. 59 south to its intersection with Parker Dr.; thence follow Parker Dr. northwest to its intersection with Soell Dr., thence follow Soell Dr. northeast to its intersection with 11th Ave.; thence follow 11th Ave. northwest to its intersection with North St.; thence follow North St. southwest to its intersection with Lincoln St.; thence follow Lincoln St. west to its intersection with 11th St.; thence follow 11th St. north to Washington Ave.; thence follow Washington Ave. east to Fuschia St.; thence follow Fuschia St. north to Harrison Ave.; thence follow Harrison Ave. east to its intersection with a canal leading into the southern branch of the Abita River; thence follow the canal north to its intersection with the southern branch of the Abita River; thence follow the southern branch of the Abita River east and southeast to its intersection with the Tammany Trace; thence follow the Tammany Trace southwest to its intersection with Hoffman Rd.; thence follow Hoffman Rd. west to its intersection with Hwy. 59, also the point of beginning.

Precinct A03. Commence at the intersection of Allen Rd. and Lowe Davis Rd., also the point of beginning; thence follow Lowe Davis Rd. northeast and east to its intersection with Beef Branch; thence follow Beef Branch southeast, south, southwest, and south to its intersection with an unnamed stream north of Hwy. 435 (Talisheek Hwy.); thence follow the unnamed stream west and southwest to its intersection with McIntyre Rd.; thence follow McIntyre Rd. southeast crossing Hwy. 435 (Talisheek Hwy.) and becoming Keen Rd.; thence follow Keen Rd. continuing southeast to its intersection with Abita Creek; thence follow Abita Creek southwest to its intersection with the Abita River; thence follow the Abita River northeast and southeast to its intersection with an unnamed road

north of Burvant St.; thence follow the unnamed road southwest and south to its intersection with Burvant St.; thence follow Burvant St. southwest and west to its intersection with Hwy. 435 (Talisheek Hwy.); thence follow Hwy. 435 (Talisheek Hwy.) north and northeast to its intersection with Allen Rd.; thence follow Allen Rd. northeast to its intersection with Lowe Davis Rd., also the point of beginning.

Precinct A04. Commence at the intersection of Hwy. 59 and Maple St. also the point of beginning; thence follow Hwy. 59 west to a curve, thence south to its intersection with the Abita River; thence follow Abita River west and northwest to its intersection with a northwestern branch of said river; thence follow said northwestern branch of the Abita River north, northwest to its intersection with Hwy. 36; thence follow LA Hwy 36 east and southeast as it becomes Maple St.; thence follow Maple St. south to its intersection with Hwy. 59, also the point of beginning.

Precinct C01. Commence at the intersection of West 21st Ave. and Menetre Dr. in the City of Covington, also the point of beginning; thence follow Menetre Dr. southwest, south, and southwest to its intersection with the Tchefuncte River; thence follow the Tchefuncte River west, northwest, west, north, northeast, and north to its intersection with US Hwy. 190; thence follow US Hwy. 190 east to its intersection with West 21st Ave.; thence follow West 21st Ave. southeast to its intersection with Menetre Dr., also the point of beginning.

Precinct C02. Commence at the intersection of Menetre Dr. and West 15th Ave. in the City of Covington, also the point of beginning; thence follow West 15th Ave. southeast to its intersection with South Jefferson Ave.; thence follow South Jefferson Ave. southwest to its intersection with West 8th Ave.; thence follow West 8th Ave. northwest to its intersection with an unnamed creek northeast of the Tchefuncte River; thence follow the unnamed creek southeast and southwest to its intersection with the Tchefuncte River; thence follow the Tchefuncte River northwest, north, and northwest to its intersection with Cleveland St.; thence follow Cleveland St. northeast and north to its intersection with West 15th Ave., also the point of beginning.

Precinct C03. Commence at the intersection of West 15th Ave. and Menetre Dr. in the City of Covington, also the point of beginning; thence follow Menetre Dr. north and northeast to its intersection with West 21st Ave.; thence follow West 21st Ave. southeast to its intersection with North Jefferson Ave.; thence follow North Jefferson Ave. southwest to its intersection with West 15th Ave.; thence follow West 15th Ave. northwest to its intersection with Menetre Dr., also the point of beginning.

Precinct C04. Commence at the intersection of South Jefferson Ave. and West 21st Ave. in the City of Covington, also the point of beginning; thence follow West 21st Ave. southeast to its intersection with East Boston St.; thence follow East Boston St. continuing northeast to its intersection with North Vermont St.; thence follow North Vermont St. south to its intersection with South Jahncke Ave.; thence follow South Jahncke Ave. southwest and southeast to its intersection with Old Landing Rd.; thence follow Old Landing Rd. southwest and south to its intersection with Riverview Dr.; thence follow Riverview Dr. east to its intersection with the Bogue Falaya River; thence follow the Bogue Falaya River southeast, south, and southwest to its intersection with the Tchefuncte River; thence follow the Tchefuncte River northwest, north, northeast, southeast, northeast, northwest, northeast, and northwest to its intersection with an unnamed creek northeast of the Tchefuncte River; thence follow the unnamed creek northeast and northwest to its intersection with West 8th Ave.; thence follow West 8th Ave. southeast to its intersection with South Jefferson Ave.; thence follow South Jefferson Ave. northeast to its intersection with West 21st Ave., also the point of beginning.

Precinct C05. Commence at the intersection of East Boston St. and North Vermont St. in the City of Covington, also the point of beginning; thence follow North Vermont St. south to its intersection with South Jahncke Ave.; thence follow South Jahncke Ave. southwest and southeast to its intersection with Old Landing Rd.; thence follow Old Landing Rd. southwest and south to its intersection with Riverview Dr.; thence follow

Riverview Dr. east to its intersection with the Bogue Falaya River; thence follow the Bogue Falaya River north, northeast, northwest, north, northeast, north, east, northeast, and north to its intersection with East Boston St.; thence follow East Boston St. southwest to its intersection with North Vermont St., also the point of beginning.

Precinct C06. Commence at the intersection of West 23rd Ave. and North Taylor St. in the City of Covington, also the point of beginning; thence follow North Taylor St. northeast to its intersection with North Columbia St.; thence follow North Columbia St. northwest to its intersection with Hwy 190; thence follow Hwy. 190 southwest and west to its intersection with West 21st St.; thence follow West 21st St. southeast to its intersection with North Lincoln St.; thence follow North Lincoln St. northeast to its intersection with West 23rd Ave.; thence follow West 23rd Ave. southeast to its intersection with North Taylor St., also the point of beginning.

Precinct C06A. Commence at the intersection of West 23rd Ave. and North Tyler St. in the City of Covington, also the point of beginning; thence follow North Tyler St. northeast to its intersection with North Columbia St.; thence follow North Columbia St. northwest to its intersection with North Taylor St.; thence follow North Taylor St. southwest to its intersection with West 23rd Ave.; thence follow West 23rd Ave. southeast to its intersection with North Tyler St., also the point of beginning.

Precinct C07. Commence at the intersection of West 23rd Ave. and North Tyler St. in the City of Covington, also the point of beginning; thence follow North Tyler St. northeast to its intersection with North Columbia St.; thence follow North Columbia St. southeast to its intersection with North Jefferson Ave.; thence follow North Jefferson Ave. southwest to its intersection with East 23rd Ave.; thence follow East 23rd Ave. northwest becoming West 23rd Ave. to its intersection with North Tyler St., also the point of beginning.

Precinct C08. Commence at the intersection of West 33rd Ave. and North Columbia St. in the City of Covington, also the point of beginning; thence follow North Columbia St. southeast to its intersection with North Jefferson Ave.; thence follow North Jefferson Ave. southwest to its intersection with East 21st Ave.; thence follow East 21st Ave. southeast where it becomes East Boston St.; thence follow East Boston St. southeast and northeast to its intersection with the Bogue Falaya River; thence follow the Bogue Falaya River northeast, north, northwest, northeast, and north to its intersection with the Little Bogue Falaya River; thence follow the Little Bogue Falaya River east, northeast, east, and northeast to its intersection with Holly Dr.; thence follow Holly Dr. northwest to its intersection with Dogwood Ln.; thence follow Dogwood Ln. north, northeast, and north to its intersection with Johnsen Rd.; thence follow Johnsen Rd. west to its intersection with Hwy. 437 (Lee Rd.); thence follow Hwy. 437 (Lee Rd.) southwest to its intersection with East 33rd Ave.; thence follow East 33rd Ave. southwest, becoming West 33rd Ave., to its intersection with North Columbia St., also the point of beginning.

Precinct C09. Commence at the intersection of West 33rd Ave. and North Columbia St. in the City of Covington, also the point of beginning; thence follow North Columbia St. northwest and north to its intersection with Hwy. 190; thence follow Hwy. 190 northwest becoming Hwy. 25; thence follow Hwy. 25 continuing northwest to its intersection with River Rd.; thence follow River Rd. northeast, southeast, east, and southeast to its intersection with Hosmer Mill Rd.; thence follow Hosmer Mill Rd. northeast to its intersection with the Bogue Falaya River; thence follow the Bogue Falaya River southeast, south, east, northeast, southeast, east, southeast, east, south, southeast, southwest, and southeast to its intersection with Hwy. 437 (Lee Rd.); thence follow Hwy. 437 (Lee Rd.) southwest to its intersection with East 33rd Ave.; thence follow East 33rd Ave. southwest, becoming West 33rd Ave., to its intersection with North Columbia St., also the point of beginning.

Precinct C10. Commence at the intersection of West 21st Ave. and North Lincoln St, also the point of beginning; thence follow North Lincoln St. north to its intersection with West 23rd Ave.; thence follow West 23rd Ave. southeast to its intersection with

North Jefferson Ave.; thence follow North Jefferson Ave. southwest to its intersection with West 21st Ave.; thence follow West 21st Ave. northwest to its intersection with North Lincoln St, also the point of beginning.

Precinct C11. Commence at the intersection of Hwy. 190 and the Tchefuncte River, also the point of beginning; thence follow the Tchefuncte River north, northeast, and northwest to its intersection with Horse Branch; thence follow Horse Branch northeast to its intersection with an eastern branch of Horse Branch; thence follow said eastern branch of Horse Branch northeast to its intersection with Horse Branch Rd. which becomes Penn Mill Rd.; thence follow Penn Mill Rd. southeast and south to its intersection with an electric power line northwest of Covington High School; thence follow the electric power line northeast to intersection with Hwy 25; thence follow Hwy 25 southeast to its intersection with Hwy 190; thence follow Hwy 190 southwest and west to its intersection with the Tchefuncte River, also the point of beginning.

Precinct F01. Commence at the intersection of Hwy. 40 (Uneedus Rd.) and Anthony Rd., also the point of beginning; thence follow Anthony Rd. north to its intersection with Lee Settlement Rd.; thence follow Lee Settlement Rd. east to its intersection with Hay Hollow Rd.; thence follow Hay Hollow Rd. northwest, north, east, north, east, north, and northeast to its intersection with Hwy. 25; thence follow Hwy. 25 southeast to its intersection with Josephps Rd.; thence follow Josephps Rd. northeast to its intersection with the Bogue Falaya River; thence follow the Bogue Falaya River in a general southeast direction to its intersection with Morgan Branch; thence follow Morgan Branch west, southwest, northwest, west, southwest, northwest, and north to its intersection with Hwy. 40 (Uneedus Rd.); thence follow Hwy. 40 (Uneedus Rd.) southwest and west to its intersection with Anthony Rd., also the point of beginning.

Precinct MD1 . Commence at the intersection of the Tchefuncte River and Bayou De Zaire, also the point of beginning; thence follow Bayou De Zaire north, northwest, and west to its intersection with Highway 21; thence follow Highway 21 north and northeast to its intersection with Dummy Line Rd.; thence follow Dummy Line Rd. northwest to its intersection with Black River; thence follow Black River south, southwest, south, southeast and south to its intersection with the shore line of Lake Pontchartrain; thence follow the shore line of Lake Pontchartrain west, northwest, west and southwest to its intersection with the St. Tammany Parish/Tangipahoa Parish boundary line; thence follow the St. Tammany Parish/Tangipahoa Parish boundary line into Lake Pontchartrain to its intersection with the St. Tammany Parish/Jefferson Parish boundary line; thence follow the St. Tammany Parish/Jefferson Parish boundary line southeast to its intersection with a straight line extension leading into the Tchefuncte River; thence follow the straight line extension north to its intersection with the Tchefuncte River; thence follow the Tchefuncte River northeast, north, northwest, and north to its intersection with Bayou De Zaire, also the point of beginning.

Precinct M01. Commence at the intersection of the Lake Pontchartrain Causeway and the St. Tammany Parish/Jefferson Parish boundary line in Lake Pontchartrain, also the point of beginning; thence follow the St. Tammany Parish/Jefferson Parish boundary line northwest to its intersection with a straight line extension leading to the intersection of the Tchefuncte River; thence follow the Tchefuncte River northeast and east to its intersection with an unnamed canal which runs parallel with the shoreline of Lake Pontchartrain; thence follow the canal southeast, east, and southeast to its intersection with Bayou Chinchuba; thence follow Bayou Chinchuba northeast to its intersection with N. Causeway Blvd; thence follow N. Causeway Blvd south to its intersection with the Lake Pontchartrain Causeway; thence follow the Lake Pontchartrain Causeway to its intersection with the St. Tammany Parish/Jefferson Parish boundary line, also the point of beginning.

Precinct M02. Commence at the intersection of North Causeway Blvd. and Florida St. in the City of Mandeville, also the point of beginning; thence follow Florida St. southeast to its intersection with Wilkinson St.; thence follow Wilkinson St. southwest to

its intersection with Monroe St.; thence follow Monroe St. northwest to its intersection with North Causeway Blvd.; thence follow North Causeway Blvd. northeast to its intersection with East Florida St., also the point of beginning.

Precinct M03. Commence at the intersection of North Causeway Blvd. and Monroe St. in the City of Mandeville, also the point of beginning; thence follow Monroe St. southeast to its intersection with Wilkinson St.; thence follow Wilkinson St. southwest to its intersection with Lakeshore Dr.; thence follow Lakeshore Dr. northwest to its intersection where Lakeshore Dr. meets Lake Pontchartrain east of Sunset Point Park; thence follow a straight line extension into Lake Pontchartrain to its intersection with the St. Tammany Parish/Orleans Parish boundary line; thence follow the St. Tammany Parish/Orleans Parish boundary line northwest to its intersection with the St. Tammany Parish/Jefferson Parish boundary line; thence follow the St. Tammany Parish/Jefferson Parish boundary line continuing northwest to its intersection with the Lake Pontchartrain Causeway; thence follow the Lake Pontchartrain Causeway northeast becoming North Causeway Blvd. to its intersection with Monroe St., also the point of beginning.

Precinct M04. Commence at the intersection of Florida St. and Girod St. in the City of Mandeville, also the point of beginning; thence follow Girod St. southwest to its intersection with Lakeshore Dr.; thence follow Lakeshore Dr. southeast to its intersection with Little Bayou Castine; thence follow Little Bayou Castine south to its intersection with the shoreline of Lake Pontchartrain; thence follow the shoreline of Lake Pontchartrain northwest to its intersection where the shoreline meets Lakeshore Dr. east of Sunset Point Park; thence follow Lakeshore Dr. southeast to its intersection with Wilkinson St.; thence follow Wilkinson St. northeast to its intersection with Florida St.; thence follow Florida St. southeast to its intersection with Girod St., also the point of beginning.

Precinct M05 . Commence at the intersection of Girod St. and Florida St. in the City of Mandeville, also the point of beginning; thence follow East Florida St. southeast to its intersection with Atalin St.; thence follow Atalin St. southwest to its intersection with Bayou Castine; thence follow Bayou Castine southwest to its intersection where Bayou Castine flows into Lake Pontchartrain; thence follow a straight line extension into Lake Pontchartrain south to its intersection with the St. Tammany Parish/Orleans Parish boundary line; thence follow the St. Tammany Parish/Orleans Parish boundary line northwest to its intersection with a straight line extension leading to a point east of Sunset Point Park; thence follow the straight line extension north to its intersection with the shoreline of Lake Pontchartrain; thence follow the shoreline of Lake Pontchartrain southeast to its intersection with Little Bayou Castine; thence follow Little Bayou Castine north to its intersection with Lakeshore Dr.; thence follow Lakeshore Dr. northwest to its intersection with Girod St.; thence follow Girod St. northeast to its intersection with Florida St., also the point of beginning.

Precinct M06. Commence at the intersection of West Causeway Approach Hwy. and Hwy. 22, also the point of beginning; thence follow Hwy. 22 northwest to its intersection with Heavens Dr.; thence follow Heavens Dr. south, southeast, and south to its intersection with Garden Ave.; thence follow Garden Ave. northeast to its intersection with Moss Ln.; thence follow Moss Ln. northwest to its intersection with Azalea Dr.; thence follow Azalea Dr. southwest to its intersection with Jasmine Dr.; thence follow Jasmine Dr. northwest to its intersection with Lotus Dr. North; thence follow Lotus Dr. North north and southeast to West Causeway Approach U Turn; thence follow West Causeway Approach U Turn northeast to West Causeway Approach Hwy.; thence follow West Causeway Approach Hwy. northwest to its intersection with Hwy. 22, also the point of beginning.

Precinct M06A. Commence at the intersection of Garden Ave. and Moss Ln.; thence follow Moss Ln. northwest to its intersection with Azalea Dr.; thence follow Azalea Dr. southwest to its intersection with Jasmine Dr.; thence follow Jasmine Dr. northwest to its intersection with Lotus Dr. North; thence follow Lotus Dr. North north and southeast to West Causeway Approach U Turn; thence follow West Causeway Approach U Turn

northeast to West Causeway Approach Hwy.; thence follow West Causeway Approach Hwy. southeast to its intersection with Garden Ave.; thence follow Garden Ave. southwest to its intersection with Moss Ln., also the point of beginning.

Precinct M07. Commence at the intersection of North Causeway Blvd. and Hwy. 190, also the point of beginning; thence follow Hwy. 190 north to its intersection with Asbury Dr. (aka LA Hwy 3228); thence follow Asbury Dr. southeast to Emerald Dr. also US Hwy 190; thence follow US Hwy 190 southeast its intersection with East Causeway Blvd.; thence follow East Causeway Blvd. northwest to its intersection with Florida St.; thence follow Florida St. northwest to North Causeway Blvd.; thence follow North Causeway Blvd. North to US Hwy. 190, also the point of beginning.

Precinct M08. Commence at the intersection of Hwy. 22 and West Causeway Approach Hwy., also the point of beginning; thence follow West Causeway Approach Hwy. southeast to its intersection with Bayou Chinchuba; thence follow Bayou Chinchuba northeast to its intersection with North Causeway Blvd.; thence follow North Causeway Blvd. north and northeast to its intersection with Hwy. 22; thence follow Hwy. 22 northwest to its intersection with West Causeway Approach Hwy., also the point of beginning.

Precinct M09. Commence at the intersection of Florida St. (a.k.a. Highway 190) and Atalin St., also the point of beginning, thence follow Atalin St. south to its intersection with Bayou Castine; thence follow the meanderings of Bayou Castine northeast to its intersection with Florida St. (a.k.a. Highway 190); thence follow Florida St. (a.k.a. Highway 190) northwest to its intersection with Atalin St., also the point of beginning.

Precinct M09A. Commence at the intersection of Florida St. (a.k.a. Highway 190) and Bayou Castine; thence follow the meanderings of Bayou Castine north northeast to its intersection with a drainage canal; thence follow the drainage canal north and northwest to its intersection with Austerlitz St.; thence follow Austerlitz St. to its intersection with Soult St.; thence follow Soult St. southwest to its intersection of Florida St. (a.k.a. Highway 190); thence follow Florida St. (a.k.a. Highway 190) southeast to its intersection with Bayou Castine, also the point of beginning.

intersection with Gum Bayou; thence follow Gum Bayou southwest and southeast to its intersection with Hwy. 11; thence follow Hwy. 11 southwest to its intersection with 5th Ave.; thence follow 5th Ave. northwest to its intersection with 8th St.; thence follow 8th St. northeast to its intersection with Pearl River St.; thence follow Pearl River St. west to its intersection with 12th St.; thence follow 12th St. southwest to its intersection with 4th Ave.; thence follow 4th Ave. northwest to its intersection with 15th St.; thence follow 15th St. northeast and northwest to its intersection with Pearl River St.; thence follow Pearl River St. west to its intersection with 17th St.; thence follow 17th St. southwest to its intersection with 3rd Ave.; thence follow 3rd Ave. northwest and west to its intersection with Receiving Station Rd.; thence follow Receiving Station Rd. northwest and west to its intersection with Bayou Vincent; thence follow Bayou Vincent south, southwest, southeast, southwest, south, and southwest to its intersection with Browns Village Rd.; thence follow Browns Village Rd. east to its intersection with Hwy. 11, also the point of beginning.

Precinct 915. Commence at the intersection of I-12 and Bayou Liberty, also the point of beginning; thence follow Bayou Liberty northwest to its intersection with the east branch of Bayou Liberty south of Belair subdivision; thence follow the east branch of Bayou Liberty north, northeast, east, northeast, and north to its intersection with Journey Rd.; thence follow Journey Rd. northwest, west, and northwest to its intersection with the west branch of Bayou Liberty; thence follow the west branch of Bayou Liberty northwest, north, and northwest to its intersection with CC19 Rd.; thence follow CC19 Rd. southeast and south to its intersection with an unnamed gravel road north of Camp Villere; thence follow the unnamed gravel road west to its intersection with Camp Villere Rd.; thence follow Camp Villere Rd. southeast, southwest, and south to its intersection with I-12; thence follow I-12 west and northwest to its intersection with Bayou Liberty, also the point of beginning.

Precinct 916. Commence at the intersection of the Tammany Trace and Hwy. 190 (Gause Blvd. West), also the point of beginning; thence follow Hwy. 190 (Gause Blvd. West) southeast to its intersection with North Harrison Rd.; thence follow North Harrison Rd. northwest to its intersection with Lagrange Rd.; thence follow Lagrange Rd. northeast to its intersection with a drainage canal which flows into Bayou Vincent; thence follow the meanderings of the Bayou Vincent Drainage Canal northwest, north, and northwest to its intersection with I-12; thence follow I-12 west to its intersection with the extension of Camp Villere Rd.; thence follow the extension of and Camp Villere Rd. south to its intersection with the Tammany Trace; thence follow the Tammany Trace west to its intersection with Hwy. 190 (Gause Blvd. West); also the point of beginning.

Precinct 917. Commence at the intersection of Hwy. 433 (Thompson Rd.) and Bayou Paquet Rd., also the point of beginning; thence follow Bayou Paquet Rd. northwest to its intersection with Bayou Paquet; thence follow the meanderings of Bayou Paquet in a general north and northwest direction to its intersection with Park Ave.; thence follow Park Ave. northeast and north to its intersection with the Tammany Trace; thence follow the Tammany Trace east to its intersection with a Drainage Canal which encircles Ozone Woods subdivision; thence follow the meanderings of the Drainage Canal southwest and southeast encircling Ozone Woods subdivision to its intersection with Hwy. 433 (Thompson Rd.); thence follow Hwy. 433 (Thompson Rd.) southwest to its intersection with Bayou Paquet Rd., also the point of beginning.

Precinct 918. Commence at the intersection of Highway 190 Business (Shortcut Highway) and Doubloon Branch; thence follow the meanderings of Doubloon Branch south, southeast, southwest, west, northwest, south, southeast, west, and southwest to its intersection with the W-14 canal; thence follow the W-14 canal southeast, southwest, and south to an extension of the W-14 canal; thence follow the extension of the W-14 canal to its intersection where the extension of the W-14 canal flows into Lake Pontchartrain; thence follow a straight line extension south to the St. Tammany Parish/Orleans Parish boundary line; thence follow the St. Tammany Parish/Orleans Parish boundary line southeast, east, northeast, east, southeast, northeast, and southeast

to its intersection with the St. Tammany Parish/St. Bernard Parish boundary line; thence follow the St. Tammany Parish/St. Bernard Parish boundary line continuing southeast then east and northeast through Lake Borgne to its intersection with the St. Tammany Parish boundary line at the Louisiana/Mississippi border; thence follow the Louisiana/Mississippi border west and northwest to the mouth of the Pearl River; thence follow the meanderings of the Pearl River northwest, west, southwest, west, northwest, and north to its intersection with Hwy 90; thence follow Hwy 90 west and southwest to its intersection with Hwy 190 Business (Shortcut Highway); thence follow Hwy 190 Business (Shortcut Highway) west and northwest to its intersection with Doubloon Branch, also the point of beginning.

Precinct 921. Commence at the intersection Hwy. 11 (Pontchartrain Dr.) and Eden Isles Blvd., also the point of beginning; thence follow Eden Isles Blvd. southeast to its intersection with Oak Harbor Blvd; thence follow Oak Harbor Blvd. east, northeast, west, southwest, north, and west to its intersection with Hwy. 11 (Pontchartrain Dr.); thence follow Hwy. 11 (Pontchartrain Dr.) southwest to its intersection with Eden Isles Blvd., also the point of beginning.

Precinct 922. Commence at the intersection of I-10 and Old Spanish Trail; thence follow Old Spanish Trail southeast to its intersection with Lank St.; thence follow Lank St. and its extension east to its intersection with the W-14 canal; thence follow the W-14 canal northeast, and northwest to its intersection with the levee which encircles the new Kingspoint Subdivision; thence follow the levee south, west, north, and northeast to its intersection with Kingspoint Blvd.; thence follow Kingspoint Blvd. north and northeast to its intersection with the W-14 canal.; thence follow the W-14 canal northwest to its intersection with I-10; thence follow I-10 southwest to its intersection with Old Spanish Trail, also the point of beginning.

Precinct 922A. Commence at the intersection of I-10 and the No. 6 Canal, also the point of beginning; thence follow the No. 6 Canal southeast, northeast, and southeast to its intersection with Salt Bayou; thence follow Salt Bayou south and southwest to its intersection where Salt Bayou flows into Lake Pontchartrain; thence follow a straight line extension south to the St. Tammany Parish/Orleans Parish boundary line; thence follow the St. Tammany Parish/Orleans Parish boundary line northeast to its intersection with a straight line extension leading to the intersection of Lake Pontchartrain and an extension of the W-14 canal; thence follow the W-14 canal north and northwest to its intersection with the eastward extension of Lank St.; thence follow the eastward extension of Lank St. and Lank St. west to its intersection with Old Spanish Trail; thence follow Old Spanish Trail northwest to its intersection with I-10; thence follow I-10 southwest to its intersection with the No. 6 Canal, also the point of beginning.

BE IT FURTHER ORDAINED that Section 2-40 “Council districts – Established” of the St. Tammany Parish Code of Ordinances is hereby amended to read as follows:

Section 2-40. Council districts – Established

The reapportionment of the parish council is enacted, containing whole election precincts, with 14 single member representative districts, as described with reference to the precincts set out in Sec. 2-41. ~~which will become effective for voting purposes immediately upon final adoption, and will become effective for parish council as its governing authority according to state law, at the end of the term of the incumbent parish councilmembers. The legal descriptive boundaries by precincts for these districts are adopted herewith.~~

BE IT FURTHER ORDAINED that Section 2-41 “Same -- Boundaries” of the St. Tammany Parish Code of Ordinances, which describes the current councilmember district boundaries, is hereby repealed.

BE IT FURTHER ORDAINED that the following Section 2-41 of the St. Tammany Parish Code of Ordinances is hereby enacted to replace section repealed in the foregoing paragraph:

Sec. 2-41. Same – Boundaries

The council districts shall be as follows:

- (1) District 1 consists of precincts 103, 104A, 105, 107, 110, 111, 113, 114, 115, 116, C01, C02, C04, and C05.
- (2) District 2 consists of precincts 206, 302, 303, 304, 305, 307, 308, 309, C03, C06A, C07, C08, C09, and C10.
- (3) District 3 consists of precincts 101, 108, 118, 201, 202, 204, 207, 301, 314, C06, C11, and F01.
- (4) District 4 consists of precincts 102, 104, 106, 112, 401, 402, 404, 413, 419, 421, M06, and MD1.
- (5) District 5 consists of precincts 306, 310, 312, 405, 407, 411, 416, 417, 418, 427, 429, and 430.
- (6) District 6 consists of precincts 203, 205, 501, 502, 503, 504, 505, 601, 602, 606, 609, A01, A02, A03, and A04.
- (7) District 7 consists of precincts 408, 409, 412, 422, 430A, 701, 702, 703, 704, 706, M09A, and M10.
- (8) District 8 consists of precincts 802, 803, 805, 815, S01, S02, S03, S04, S05, S08, and S09.
- (9) District 9 consists of precincts 603, 604, 606A, 801, 804, 807, 808, 812, 817, 903, and P01.
- (10) District 10 consists of precincts 403, 410, 414, 415, 426, M01, M02, M03, M04, M05, M06A, M07, M08, M09, M11, and M12.
- (11) District 11 consists of precincts 313, 406, 420, 605, 705, 901, 905, 906, 913, 915, 916, 917, and A02A.
- (12) District 12 consists of precincts 906A, 907, 912, 921, S06, S10, S11, S13, S15, S16, S17, S18, S20, S22, and S23A.
- (13) District 13 consists of precincts 806, 808A, 810, 811, 813, 816, 909, 910, 911, 918, and 922A.
- (14) District 14 consists of precincts 809, 814, 815A, 818, 902, 903A, 904, 914, 922, S06A, S07, S19, S21, S23, S24, and S25.

BE IT FURTHER ORDAINED that the intent of the parish council in adopting this ordinance is that the precinct and council descriptions herein shall be construed to avoid any gaps, overlaps, or discrepancies between adjacent districts, and to the extent that any gaps, overlaps, or discrepancies are discovered, they shall be resolved to harmonize the descriptions herein and the reapportionment plan attached hereto.

BE IT FURTHER ORDAINED that the parish council’s redistricting counsel and consultants are directed to prepare the necessary materials to submit the reapportionment enacted by this ordinance to the Louisiana Secretary of State, and to effectuate all other required implementation steps in accordance with state law.

REPEAL: All Ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective for candidate qualifying purposes with the opening of the next qualifying period for the primary election for members of the parish council following its adoption, which is August 8, 2023. It shall be effective for the parish council to act as its governing authority according to state law at the end of the term of the incumbent parish councilmembers.

Comment

This ordinance implements the redistricting of the parish council based on the 2020 Federal Decennial Census, as mandated both by state law and the St. Tammany Parish Home Rule Charter. Because of substantial changes in the total population of the parish and differential growth rates in different areas of the parish between 2010 and 2020, major changes were required in several council districts.

To maintain district populations within the legally allowable population deviation of 5% of the ideal district size, and to respect traditional redistricting principles established by longstanding jurisprudence, the boundaries of a number of voting precincts had to be revised so that the as-revised precincts could be used as the building blocks to create the new council districts. Basing district boundaries on precincts is mandated by state law. This single ordinance revises (and in some cases corrects) the voting precinct boundaries, and then describes the new council districts based on the revised precinct descriptions. The ordinance also makes minor changes in related provisions of the St. Tammany Parish Code of Ordinances to bring the code up to date and to align the language in the code with state statutes.

The redistricting plan was developed with the advice of the parish's redistricting counsel and consultants, Butler Snow LLP and Strategic Demographics, LLC.
