ORDINANCE TO AMEND ST. TAMMANY PARISH CODE OF ORDINANCES, PART II — LAND DEVELOPMENT CODE, CHAPTER 130 — UNIFIED DEVELOPMENT CODE, ARTICLE II — ADMINISTRATION AND ENFORCEMENT, DIVISION 1 — GENERALLY, SECTION 130-32 — BOARD OF ADJUSTMENTS, TO PROVIDE PER DIEM COMPENSATION TO MEMBERS OF THE BOARD OF ADJUSTMENT

WHEREAS, the St. Tammany Parish Board of Adjustment is created pursuant to St. Tammany Parish Code of Ordinances Sec. 130-32 in accordance with Act 518 of 1954 of the Louisiana State Legislature, and is charged with considering appeals and applications to vary the provisions of ordinances relating to the construction or alteration of buildings or structures were there are practical difficulties or unnecessary hardships in carrying out the strict letter of such ordinance; and

WHEREAS, the Board of Adjustment meets at least once a month to hear requests for variances and appeals in connection with their duties under Sec. 130-32; and

WHEREAS, in addition to attending monthly meetings, members of the Board of Adjustment also spend time reviewing the staff reports and related documents for the docketed cases and making site visits when necessary; and

WHEREAS, appointed members of the St. Tammany Planning and Zoning Commissions receive a per diem of \$50.00 per meeting for a maximum of 24 meetings per year; and

WHEREAS, it is believed that adequate funding for the per diem compensation can and should be allocated from fees collecting by the Department of Planning from applications submitted for review by the Board of Adjustment; and

WHEREAS, the Board of Adjustment passed a resolution to support the introduction of an ordinance by the St. Tammany Parish Council to provide commensurate per diem compensation to members of the Board of Adjustment, including alternate members in attendance, in recognition of the time and personal expense incurred to carry out their duties as members of the Board.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that St. Tammany Parish Code of Ordinances, Part II – Land Development Code, Chapter, 130 – Unified Development Code, Article II – Administration and Enforcement, Division 1 – Generally, Section 130-32 – Board of Adjustment, be amended to add subsection (a)(9), to provide a per diem compensation for Board of Adjustment members as provided herein:

(a) Creation of board.

. . .

(9) Board of adjustment members, including alternate members, shall receive a per diem of \$50.00 for each meeting of the board attended, for a maximum of 24 meetings per year.

REPEAL: All Ordinances or parts of Ordinances in conflict herewith are hereby repealed.
