ORDINANCE TO AMEND THE PARISH CODE OF ORDINANCES, PART I, CHAPTER 26 – NUISANCES TO AMEND ARTICLE III. – BLIGHTED PROPERTY, DERELICT AND DANGEROUS BUILDINGS AND OTHER DANGEROUS STRUCTURES PROHIBITED.

WHEREAS, blighted, derelict and dangerous properties pose a threat to the public health, safety, and welfare of the residents of St. Tammany Parish; and

WHEREAS, the St. Tammany Parish Council, the governing authority of St. Tammany Parish Government, may promulgate ordinances to promote the public health, safety and welfare; and

THE PARISH OF ST. TAMMANY HEREBY ORDAINS that it amends the Code of Ordinances, Part I, Chapter 26 – Nuisances, to amend Article III. – Blighted Property, Derelict and Dangerous Buildings and Other Dangerous Structures Prohibited as set forth in the attached **Exhibit "A"**.

REPEAL: All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this ordinance are hereby declared severable.

EFFECTIVE DATE: This ordinance shall become effective fifteen (15) days after adoption.
