ORDINANCE TO AMEND THE 2025 CAPITAL IMPROVEMENT BUDGET AND CAPITAL ASSETS - AMENDMENT NO. 27
SALES TAX DISTRICT 3 CAPITAL PROJECTS

WHEREAS, St. Tammany Parish has prepared a capital improvement budget and capital asset list in accordance with the Home Rule Charter.

WHEREAS, the Parish has identified additional capital improvements, capital assets, and/or grant-funded improvements for Fiscal Year 2025.

ADMINISTRATIVE COMMENT
AMENDMENT NO. 27 - 2025 CAPITAL IMPROVEMENTS - NOVEMBER 2025

SECTION I: CAPITAL IMPROVEMENTS - INFRASTRUCTURE (ROADS, BRIDGES, DRAINAGE, AND UTILITIES)

Carroll Rd.

Scope: Carroll Rd. is a 1.26 mile major connector road between LA433 and US190. The route also includes Carolyn Park Middle School and multiple commercial businesses. This project intends to implement roadway improvements recommended by a corridor evaluation that was completed in 2023 under the Carroll Rd. Corridor Traffic Analysis project.

The corridor evaluation recommended improvements at the Preacher’s Oak Ln. intersection, Carolyn Park Access/West Dr. intersections, Garden Dr. and Hall Ave. intersections. The evaluation also recommended the closure of several open ditches, widening of the roadway, and a southbound right turn lane at LA433. Engineering is in the process of requesting the NORPC to program the project for Federal Aid.

Status: This budget request is to reallocate a portion of the funding from the Oak Harbor Blvd Turn Lane project, to put toward the future construction match that will be required with the Federal Aid.

Casril Dr. Drainage

Scope: Drainage improvements along Casril Dr. from Soell Dr. to LA59. Improvements include replacement of driveway culverts, some subsurfacing of open ditch, roadside ditch improvements, and replacement of cross culverts. Due to the drainage work, road will be milled and overlaid after the drainage work is complete.

Status: Final design has been completed. This budget request is to proceed with project construction.

Harrison Ave. Drainage

Scope: Project includes improvements to major drainage crossings on Harrison Ave. This currently focuses on the crossing located at Harrison Ave. and C St. The existing crossing has large catch basins condensing down to smaller cross drain pipes causing inefficiencies and constant maintenance for accumulated debris. This project could expand in the future as additional crossings are identified and also includes resolving any utility conflicts that may arise.

Status: This budget request is for specialty services that will be needed for the in-house design of the drainage crossing and construction costs.

Harrison Ave. Mill & Overlay

Scope: Project consists of a mill and overlay with patching of Harrison Ave. between I St. and LA59. The remaining portion of Harrison Ave. between US190 and I St. is part of a phased corridor project scheduled for construction late 2026/early 2027.

Status: Project construction bids came in much lower than estimated. This amendment is to reduce the project funding leaving the bid cost plus contingency.
