WHEREAS, St. Tammany Parish Government seeks to initiate a sale of the tax-adjudicated properties through Archon Information Systems, LLC d/b/a CivicSource and/or any other method provided by Louisiana law to the City of Slidell.
THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that pursuant to all applicable provisions of law, the Office of the Parish President is authorized to assess, deem, designate and determine that such immovable properties annexed hereto are surplus; and
BE IT FURTHER ORDAINED: that the Office of the Parish President is authorized to proceed with the advertising and selling of 111 Westchester Place, Slidell, La, having Assessment No. 6240500569 through Archon Information Systems, LLC d/b/a CivicSource to the City of Slidell as a qualifying, adjoining land owner at private sale and/or via any other method provided by Louisiana law, on such date and time as designated by the Office of the Parish President; and
BE IT FURTHER ORDAINED: that any and all actions previously taken by the Office of the Parish President in furtherance of the actions contemplated herein are ratified and accepted accordingly.
REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.
SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.
