Allocate additional funds for the design of a nature park area along the Tammany Trace in Lacombe. Total project funding is \$311,370.40 as follows: \$130,970.40 from HUD Entitlement Grant funds for cultural resource and environmental assessments, and \$180,400.00 from Capital Projects fund 253 - Deep Water Horizon.
