WHEREAS, Jenkins Homes, Inc. (the "Owner") is owner of a certain parcel approximately thirty five (35') feet in width and running west off Highway 1077 near Folsom (the "Property"); and		
WHEREAS, the Property is more fully depicted as "Bennett Cemetery Road" on the Survey of Parcel 3A1 Situated in Section 31, Township 5 South, Range 10 East, St. Tammany Parish, Louisiana by Randall W. Brown, P.L.S. dated May 10, 2022; and		
WHEREAS, Owner has requested and Parish desires to accept the dedication and donation of the Property in consideration of the use of the Property as a public road; and		
WHEREAS, there is a need and a public purpose for the acquisition of the Property for furthe enhancement of public road access in the area.		
THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that St. Tammany Parish Government through the Office of the Parish President, is authorized to acquire by an Act of Dedication and Donationall that certain property of approximately thirty-five (35') feet in width and depicted as "Bennett Cemeter Road" on the Survey of Parcel 3A1 Situated in Section 31, Township 5 South, Range 10 East, St. Tammany Parish, Louisiana by Randall W. Brown, P.L.S. dated May 10, 2022 (the "Property"); and		
BE IT FURTHER ORDAINED: that the Office of the Parish President is hereby authorized to exercise its discretion in acquiring the Property and/or all related rights-of-way, infrastructure and/o servitudes, together with signing all documents, agreements and transactions necessary to carry out the intent of this Ordinance; and

ORDINANCE TO AUTHORIZE ST. TAMMANY PARISH GOVERNMENT, THROUGH THE OFFICE OF THE PARISH PRESIDENT, TO ACCEPT AN ACT OF DEDICATION AND DONATION FOR A PORTION OF BENNETT CEMETERY ROAD (WARD 1, DISTRICT 3)

The Parish seeks to acquire a formal dedication of right-of-way over this portion of Bennett Cemetery Road, which is already a tacitly-dedicated road in Parish's road maintenance system. Acquiring a formal dedication from a tacit dedication formalizes what Parish already owns and eliminates disputes as to right-of-way limits.
