AN ORDINANCE TO OFFICIALLY NAME THE 35-FOOT RIGHT-OF-WAY IDENTIFIED ON THE ATTACHED SURVEY COMPASS POINT (WARD 4, DISTRICT 4).

WHEREAS, a petition has been submitted to the Department of Planning & Development and forwarded to the Parish 911 Communications District signed by at least 50 percent plus one of the property owners owning or fronting the 35-foot Right of Way has been submitted; and

WHEREAS, the St. Tammany Parish 911 Communications District has received, reviewed and approved the Road Name Request Form for the unnamed 35-foot Right of Way. Pending Approved Name: Compass Point, Nearest Cross-street: Del Oaks Road, Madisonville LA 70447. Since future structures will be addressed off the newly name 35-foot Right of Way; the Right of Way will be added to the 911 Database and to the 911 Dispatch Map;

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that St. Tammany Parish Government officially name the 35-foot Right of Way shown on the attached survey as Compass Point.

REPEAL: ALL ordinances or part of ordinances herewith are hereby repealed.

SEVERABILITY: if any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.
