- 3. Remove Green Thumb Lane (R02K037) private
- 4. Remove Jacqueline Ct. (R03C010) Annex 85-01
- 5. Remove 19<sup>th</sup> St. Bridge (R03C507) City of Covington- wrong ID #

REPEAL: All Ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.
