ORDINANCE LEVYING ADJUSTED MILLAGES FOR THE YEAR 2024

WHEREAS, the Home Rule Charter for St. Tammany Parish Section 2-11 (3) requires an ordinance to levy taxes, assessments and charges.

TAMMANY HEREBY ORDAINS that in a public meeting held on <u>September 5, 2024</u>, which meeting was conducted in accordance with the Open Meetings Law and the additional requirements of Article VII, Section 23(C) of the Louisiana Constitution and R.S. 47:1705(B), that the following **adjusted** millage rates are hereby levied upon the dollar of the assessed valuation of all property subject to ad valorem taxation within said Parish for the year 2024, for the purpose of raising revenue:

ADMINISTRATIVE COMMENT MILLAGE ORDINANCE – JULY 2024

Fiscal year 2024 is a reassessment year for St. Tammany Parish. All property subject to taxation is to be reappraised and valued at least once every 4 years. This is done under the authority of each parish Assessor and/or the Louisiana Tax Commission. Reassessment adjusts the millage rate upward or downward depending on property value and keeps the total amount of ad valorem taxes collected by a taxing authority the same as the preceding year, which results in the adjusted millage. Any rate up to and including the adjusted maximum millage may be levied without going through the roll forward process.

The Assessor's Office has provided the adjusted millage rates for each of the millages for Parish Government as shown below. In addition, the estimated cost to a home valued at \$300,000 is shown for each millage.
