ORDINANCE TO REMOVE ROADS AND/OR PORTIONS OF ROAD IN DISTRICT 6 THAT HAVE NOT BEEN MAINTAINED BY PARISH FORCES

WHEREAS, the St. Tammany Parish Selective Road and Drainage Inventories require updating/amending periodically for the corrections/additions/deletions to the road and drainage inventories based upon the recommendations of the Department of Engineering, Director of Public Works, 911 Facilitator, or Certificate of Road and/or Drainage Maintenance by Area Foreman, Act of Exchange and/or Act of Donation.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that the St. Tammany Parish Selective Road and Drainage Maintenance System is amended as follows:

- 1. Remove O'Keefe Rd. (R02N023) never maintained
- 2. Remove Dump Rd. (R02U001) gated and private
- 3. Remove Alvin Revere Rd. (R02S005) private

REPEAL: All Ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.
