ADMINISTRATIVE COMMENT AMENDMENT NO. 31 - 2024 CAPITAL IMPROVEMENTS - AUGUST 2024

SECTION I: CAPITAL IMPROVEMENTS - INFRASTRUCTURE (ROADS, BRIDGES, DRAINAGE, AND UTILITIES)

PARISHWIDE ROADS & DRAINAGE

Coin Du Lestin Estates Road Elevation

Scope: Project will elevate and/or improve multiple specified roadway locations throughout Coin Du Lestin that have become inundated with water, preventing ingress and egress during major rain events. These areas include the end of Faciane Ln., the end of Legardeur Dr., the intersection of Legendre Dr. and Legardeur Dr., Legendre Dr. from addresses 507 to 514 and 516 to 524, the intersection of Legendre Dr. and Bea Dr., Legendre Dr. between Nunez Rd. and Peninsula Dr., and Laurent Rd. between Coin Du Lestin Rd. and Ball Park Rd. Raising the roadways would improve the ability for residents to evacuate during major events.

Status: An evaluation of the road raisings throughout the Coin Du Lestin subdivision was completed in March 2022. The evaluation determined feasible roadway improvement options at multiple locations in the subdivision. The estimated construction cost for this project is \$1,565,000.00. Design is complete and the project is ready to bid.

Sharp Rd.

Scope: Project includes the design and construction of Sharp Rd. from LA59 to Asbury Dr. Work includes roadway reconstruction and subsurface drainage. Due to the scope and scale of work, this project will be constructed in phases. Phase 1 was a complete reconstruct of Sharp Rd. from Lochmere Dr. through the curve to Fox Run Dr., and included drainage improvements at the crossing and sub-surfacing of the ditches. It also included safety improvements with the addition of a guardrail in the curve and at the crossing, and new roadway striping. Phase 3 will include the addition of a sidewalk on the north side of Sharp Rd. from the Tammany Trace to Carriage Estates subdivision, and will include concrete walks, ADA ramps, and a pedestrian bridge.

Status: Phase 2 of Sharp Rd. will include reconstruction of road and subsurface drainage for the remaining portion of the roadway. The Parish has received Capital Outlay funding to be used towards this project phase. Phase 2 has a construction estimate of \$9,733,326.63 and is ready to go out for bid.

DISTRICT 1

Loop Detection System-Stirling Blvd.

Scope: Project will install a loop detection system to replace the existing, inoperable camera system for the traffic signal at the intersection of Brewster Rd. and Stirling Blvd. Previous traffic system was installed in early 2011 and used a camera system mounted to the signal cross beams. This camera system will be replaced with loop detectors, which are circular loops that are cut into the asphalt and use magnetic fields to detect when vehicles are located above them.

Status: Estimated time for completion will be 10-12 months once approved.
