ORDINANCE LEVYING DECREASED MILLAGE RATES FOR THE YEAR
2024 THE ST. TAMMANY PARISH CORONER.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS that in a public meeting held on September 5, 2024, which meeting was conducted in accordance with the Open Meetings Law and the additional requirements of Article VII, Section 23(C) of the Louisiana Constitution and R.S. 47:1705(B), that the Parish Council voted to decrease the millage rates on all taxable property shown on the official assessment roll for the year 2024, and when collected, the revenues from said taxes shall be used only for the specific purposes for which said taxes have been levied. Said millage rates are:

ADMINISTRATIVE COMMENT
MILLAGE ORDINANCE – JULY 2024

The millage for St Tammany Parish Coroner’s Office is proposed to be reduced. This millage is for construction, acquiring, improving, operating, and maintaining facilities and equipment therefore. The authorized levy period is from 2005-2024.

The estimated amount of tax revenues to be collected in the next tax year is \$7,602,903, a decrease of \$1,303,355. These amounts are presented gross before deductions for pension assessment fees and uncollectible accounts. The estimated cost to a home valued at \$300,000 is \$55.13, a decrease of \$9.45.
