CAPITAL PROJECTS - 203 - COASTAL RESTORATION

Materials of Opportunity

Scope: St. Tammany Parish seeks approval of Restore Act funding. Purpose of the funding may include planning/feasibility studies; engineering and design; permitting; geotechnical and surveying; land rights investigations (not acquisition); cost share execution; material analysis; acquisition; storage, preparation, and transport; communications/outreach; project bidding; construction/implementation; and/or post-construction monitoring.

The program seeks to provide materials to support the construction and implementation of various coastal centric projects along/near Lake Pontchartrain that will restore and replenish habitat as well as provide additional layers of defense against storm surge such as shoreline protection, living shorelines, marsh and beach creation and/or nourishment, and tree plantings/recycling. For each of these initiatives, obtaining construction materials from the open market can be a primary driver for project cost. Additionally, these various materials would otherwise be discarded in landfills and sometimes illegally. The program seeks to create processes and partnerships to maximize the re-utilization of these materials into much needed coastal projects and assist in implementation efforts.

Status: Estimated time of completion is approximately 36 months or three years. The grant agreement with the U.S. Department of the Treasury for the Restore Act allocation is pending. The budget will be posted and available after the agreement is executed by both the St. Tammany Parish and the Trustee.
