Administrative Comment Amendment No. 13 - 2025 Operating Budget - August 2025

This budget amendment is to:

a. 502 - UTILITY OPERATIONS FUND

FUNDING SOURCE: CHARGES FOR SERVICES

To amend the budget by \$7,000,000.00 for the DEQ Revolving Loan obtained for the construction of the Goodbee Regional Wastewater Treatment Plant. This project will allow for the construction of a new 350,000 gallon per day WWTP. The existing WWTP will be decommissioned upon completion of the construction of the new treatment plant. The project will provide much needed wastewater treatment capacity for the area. Total project budget is \$9,932,492.00.
