RESOLUTION SUPPORTING AND AUTHORIZING THE PARISH PRESIDENT TO ENTER INTO COOPERATIVE ENDEAVOR AGREEMENTS WITH THE MUNICIPALITIES LOCATED WITHIN THE PARISH OF ST. TAMMANY, AND TO ABIDE WITH AND CONFORM TO ALL THE TERMS AND CONDITIONS OF THE HOUSING AND COMMUNITY DEVELOPMENT ACT OF 1974, AS AMENDED AND THE HOME INVESTMENT PARTNERSHIP ACT OF 1990

WHEREAS, the Housing and Community Development Act of 1974, as amended, and the HOME Investment Partnerships Act of 1990 are based upon Cooperative Agreements between qualified urban counties (parishes) and the municipalities located within said counties (parishes); and

WHEREAS, these Cooperative Agreements will allow the Parish to undertake, or assist in undertaking, essential community renewal and lower income housing assistance activities, and will allow the Parish to have final responsibility for selecting activities and projects and submitting the Consolidated Plan and all annual Action Plans and Amendments to HUD; and

WHEREAS, the Parish of St. Tammany, under the Housing and Community Development Act of 1974, as amended and the HOME Investment Partnership Act of 1990, has urban county status and desires to enter into Cooperative Agreements with its municipalities as required by said laws; and

WHEREAS, these Cooperative Agreements will allow the Parish to undertake, or assist in undertaking, essential community renewal and lower income housing assistance activities, and will allow the Parish to have final responsibility for selecting activities and projects and submitting the Consolidated Plan and all Annual Action Plans and Amendments there to HUD.

THE PARISH OF ST. TAMMANY HEREBY RESOLVES that by the St. Tammany Parish Council acting in its capacity as the governing authority that the Parish President is hereby authorized to enter into Cooperative Agreements with the following municipalities located with the Parish of St. Tammany: Town of Abita Springs, City of Covington, Village of Folsom, City of Mandeville and Village of Sun, to abide with and conform to all of the terms and conditions of the Housing and Community Development Act of 1974, as amended, and the HOME Investment Partnership Act of 1990.

Grants Department

HUD has identified St. Tammany Parish as an urban county. Urban Counties are entitlement communities under the CDBG Entitlement Program. In accordance with HUD regulations, every three years urban counties (parishes) receiving CDBG funds must requalify. This includes notifying local governing bodies their option to accept or defer status of an entitlement grantee with St. Tammany Parish. Those who accept will enter into a Cooperative Endeavor Agreement. Participation is not required for local governing bodies; However, participation does help in determining the allocation amounts for the CDBG and HOME grants that are awarded to St. Tammany Parish. For local governing bodies who wish to participate, will allow low-to-moderate residents to access CDBG funded projects.
