A RESOLUTION APPROVING THE HOLDING OF AN ELECTION IN ST. TAMMANY PARISH RECREATION DISTRICT NO. 11, STATE OF LOUISIANA, ON SATURDAY, NOVEMBER 15, 2025, TO AUTHORIZE THE LEVY OF A SPECIAL TAX THEREIN.

WHEREAS, the Board of Commissioners of St. Tammany Parish Recreation District No. 11, State of Louisiana (the "Governing Authority"), acting as the governing authority of St. Tammany Parish Recreation District No. 11, State of Louisiana (the "District"), plans to call a special election in the District on Saturday, November 15, 2025, to authorize the levy of a special tax therein; and

WHEREAS, the governing authority of the District has requested that this Parish Council, acting as the governing authority of the Parish of St. Tammany, State of Louisiana, give its consent and authority for the District to hold the aforesaid election, and in the event that the election carries for further authority to levy the special tax therein; and

WHEREAS, as required by Article VI, Section 15 of the Constitution of the State of Louisiana of 1974, it is now the desire of this Parish Council to approve the holding of said election and in the event that the election carries, to authorize the District to levy and collect the special tax provided for therein;

NOW, THEREFORE, BE IT RESOLVED by the Parish Council of the Parish of St. Tammany, State of Louisiana, acting as the governing authority of said Parish, that:

SECTION 1. In compliance with the provisions of Article VI, Section 15 of the constitution of the State of Louisiana of 1974, and in accordance with the request of the Board of Commissioners of St. Tammany Parish Recreation District No. 11, State of Louisiana, this Parish Council hereby approves the holding of an election in the District, on Saturday, November 15, 2025, at which election there will be submitted the following proposition, to-wit:

PROPOSITION

(IN-LIEU MILLAGE)

Shall St. Tammany Parish Recreation District No. 11, State of Louisiana (the "District"), levy a special tax of 9.26 mills (the "Tax") on all property subject to taxation in said District (an estimated \$1,350,246 reasonably expected at this time to be collected from the levy of the Tax for an entire year), for a period of 20 years, beginning with the year 2026 and ending with the year 2045, for the purpose of acquiring, constructing, improving, maintaining or operating parks, playgrounds, recreation centers and other recreational facilities in said District, together with the necessary furnishings and equipment therefor, said tax to be in lieu of and completely replace the current 9.26 mills tax authorized to be levied pursuant to an election held on November 13, 2021?

SECTION 2. In the event the election carries, this Parish Council does hereby further consent to and authorize the District to levy and collect the special tax provided for therein.
