ORDINANCE TO RESCIND ORDINANCE COUNCIL SERIES NO. 24-5382, ADOPTED ON MARCH 07, 2024, WHICH ESTABLISHED A 'NO PARKING' ZONE AND AUTHORIZED THE PLACEMENT OF NO PARKING SIGNS ON CANAL STREET (R08G003) IN OZONE PINES SUBDIVISION. (WARD 8, DISTRICT 9)

WHEREAS, St. Tammany Parish Government is charged with protecting the safety and general welfare of citizens of the Parish; and

WHEREAS, affected citizens had requested measures to be taken to address traffic issues on a Parish road; and

WHEREAS, pursuant to the request, Ordinance Council Series No. 24-5382 was adopted by the governing authority to establish a 'No Parking' zone on Canal Street, and

WHEREAS, after further review, the installation of no parking signs has created hardships for citizens living nearby and they have requested the signs be removed, the no parking signs are not consistent with roads in the district, and it has been recommended that the no parking signs are not necessary.

NOW, THE PARISH OF ST. TAMMANY HEREBY ORDAINS that:

SECTION I: Ordinance Council Series No. 24-5382, adopted March 07, 2024, establishing a 'No Parking' zone on Canal Street (R08G003), Ward 8, District 9, is hereby rescinded and declared repealed.

SECTION II: The Parish Department of Public Works is hereby directed to remove all no parking signs installed on Canal Street (R08G003).

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.
