ORDINANCE TO CORRECT THE ROAD AND DRAINAGE INVENTORY  
TO INCLUDE PEG KELLER RD. LATERAL (D060W01031) (WARD 6,  
DISTRICT 6)

WHEREAS, the St. Tammany Parish Selective Road and Drainage inventories require update/amending periodically for corrections/additions, deletions to the road and drainage inventories based upon the recommendation of the Department of Engineering, Director of Public Works, 911 Facilitator, or Certificate of Road and/or Drainage Maintenance by Area Foreman, Act of Exchange and/or Dedication.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that the St. Tammany Parish Selective Road and Drainage Maintenance System is amended as follows:

Add Peg Keller Rd. lateral (D060W01031) for approximately 2,200 ft., runs SW off of Peg Keller Rd., down Mop Top Rd.

REPEAL: All Ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provisions of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of the Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.
