ADMINISTRATIVE COMMENT MILLAGE ORDINANCE – JULY 2024

The millage for Parish Alimony, Drainage Maintenance, and Animal Services are to the maximum authorized levy (the same as the 2023 levy), which is an increase of .42 mills on each Companion Ordinance Levying Increased Millage Rates for the Year 2024. The millage for the Coroner is being decreased by .42 mills on the Companion Ordinance Levying Decreased Millage Rates for the Year 2024. Therefore, the total levied will not exceed the prior year levy, and there is no additional cost to the taxpayers.
