TAMMANY, THROUGH THE OFFICE OF THE PARISH PRESIDENT, TO ACCEPT THE DONATION OF A PERPETUAL DRAINAGE SERVITUDE FOR DRAINAGE IMPROVEMENTS AND MAINTENANCE IN TIMBERCREEK SUBDIVISION (WARD 4, DISTRICT 10) WHEREAS, Timbercreek Property Owners Association, Inc. is the owner of a parcel situated at consisting of .814 acres situated at the terminus of Timbercreek Lane in Mandeville, said property being identified as a Park on the Plat for Timbercreek Subdivision recorded at Map File No. 1105 (the "Property"); and WHEREAS, owner seeks to dedicate and donate a drainage servitude across the Property; and WHEREAS, owner has requested and Parish desires to accept the dedication and donation of the servitude in consideration of the use of the servitude for drainage; and WHEREAS, there is a need and public purpose for the acquisition of a servitude on the Property for the improvement of drainage of surface water in the project area and/or surrounding areas. THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that the Parish of St. Tammany, through the Office of the Parish President, is authorized to acquire by donation, all or parts of a drainage servitude on .814 acres identified as a Park of the Plat for Timbercreek Subdivision recorded at Map File No. 1105 (collectively, the "Property"); and BE IT FURTHER ORDAINED: that the Office of the Parish President is authorized to exercise its discretion in acquiring the Property, together with all agreements and all transactions necessary to carry out the intent of this Ordinance; and BE IT FURTHER ORDAINED: that any and all actions previously taken by the Office of the Parish President in furtherance of the actions contemplated herein are ratified and accepted accordingly. REPEAL: All Ordinances or parts of Ordinances in conflict herewith are hereby repealed. SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.
