TAMMANY HEREBY ORDAINS: that all the area within the right-of-way, the road base, drainage ditches, culvert, laterals, canals and appurtenances belonging to or otherwise appertaining to the below indicated developments and authorized in the Resolution/Ordinance stated shall be incorporated in the Parish Maintenance System.

BE IT FURTHER ORDAINED: that all parish regulations, policies, procedures and operating methods pertain the Parish Maintenance System shall apply to the aforementioned developments:
