AMENDMENT NO. 34 - 2024 CAPITAL IMPROVEMENTS - SEPTEMBER 2024

SECTION I: CAPITAL IMPROVEMENTS - INFRASTRUCTURE (ROADS, BRIDGES, DRAINAGE, AND UTILITIES)

Square 154 Drainage

Scope: Project includes drainage improvements to the area, which may include replacement of culverts and subsurface drainage along with cleaning out of ditches along Carroll St., Lafitte St., and Caroline St. to facilitate positive drainage flow through the neighborhood. The purpose of this work is to re-establish positive drainage towards America St. and improve the conveyance of the roadside drainage features.

After obtaining and reviewing the area survey, it was determined that more improvements are required than estimated in the original assessment of the drainage. As such, the project cost has increased. Additional funds are being requested for Lafitte St. along with funds for Caroline St.

Status: Project design is complete and ready for bidding and construction. Funds for Carroll St. were previously approved and are unchanged.
