**CAPITAL PROJECTS - 211-2412 - SAFE HAVEN FACILITY**

Safe Haven Quad F/Cafeteria Building

Scope: Renovations of the existing cafeteria building on the Safe Haven Campus. The renovation will include a commercial kitchen, classroom, and lab space.

The Northshore Technical and Community College (NTCC) is partnering with St. Tammany Parish on this project. This renovation will allow an expansion of services to workforce training for the clients at Safe Haven and the larger community. The space will offer classes in healthcare, behavioral health, culinary, and other related fields.

Status: The expected project timeline is as follows:  
Building evaluation: February 2024 - June 2024  
Design: July 2024 - November 2024  
Asbestos abatement: September 2024 - December 2024  
Construction: March 2025 - December 2025
