Square 154 Drainage - Property IDs: D04D049 and D04D050

Scope: Project to improve drainage in the area, which may include replacement of culverts and subsurface drainage as well as cleaning out ditches along Carroll St. and Lafitte St. to facilitate positive drainage flow through the neighborhood. The purpose of this work is to re-establish positive drainage towards America St. and improve the conveyance of the roadside drainage features.
