Airport Rehabilitate Runway

Scope: This budget request is to increase the budget for the St. Tammany Parish Airport Runway Rehabilitation due to a change order resulting from unforeseen subsurface base course conditions. The existing base course that was to remain in place was found to be deteriorating significantly once the top course was removed. The increased budget will allow for the failing base course to be removed and re-constructed. The cost increases will be covered by increased grant funding from the FAA and LADOTD.

Status: Barriere Construction re-mobilized and resumed removal of the base on July 31, 2023. Barriere's contract was amended to expand the scope to include the base re-construction and remove the final surface course. Once the funding is approved, a change order will be executed to include the final course.
