WHEREAS, St. Tammany Parish Government is charged with protecting the safety and welfare of the citizens of St. Tammany Parish; and

THE PARISH OF ST. TAMMANY HEREBY ORDAINS:

A "No Parking on Roadway" zone is hereby established on Harvey Dr. and Wadsworth Parkway.

The Parish Department of Public Works is directed to post the appropriate signage on Wadsworth Parkway (R04F075) and Harvey Dr. when warranty obligation is released.

REPEAL: All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this ordinance are hereby declared severable.
