ORDINANCE LEVYING MILLAGE RATES FOR THE LIBRARY FOR FISCAL YEAR 2026.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS that in a public meeting held on July 9, 2026, which meeting was conducted in accordance with the Open Meetings Law and the additional requirements of Article VII, Section 23(C) of the Louisiana Constitution and R.S. 47:1705(B), that the following **millage rates** are hereby levied upon the dollar of the assessed valuation of all property subject to ad valorem taxation within said Parish for the year 2026, for the purpose of raising revenue:

ADMINISTRATIVE COMMENT

MILLAGE ORDINANCE – JUNE 2026

The voters approved the levy of 4.35 mills for the Library, with an authorized levy period from 2025-2039, at the March 29, 2025 election. The Library millage is for the purpose of constructing, acquiring, improving, maintaining and/or operating public library facilities, furnishings and equipment, and otherwise supporting the public library system in the Parish. This millage is crucial to supporting our ability to empower, enhance and enrich the quality of life for every resident of St. Tammany Parish through services, programs, facilities, technology and physical and digital collections.
