ORDINANCE AUTHORIZING THE ST. TAMMANY PARISH GOVERNMENT, THROUGH THE OFFICE OF THE PARISH PRESIDENT, TO ENTER INTO A SERVITUDE AGREEMENT WITH CLECO POWER, LLC FOR A NEW 30' OVERHEAD ELECTRIC LINE RIGHT OF WAY ACROSS THE AREA MORE FULLY DESCRIBED IN THE SERVITUDE AGREEMENT AND SKETCH ATTACHED AS EXHIBIT A. (WARD 8, DISTRICT 9)

WHEREAS, it is the desire of St. Tammany Parish Government to grant a servitude to Cleco Power, LLC on immovable property owned by the Parish for the purpose of providing a new 30' overhead electric line right of way across the parcel on N. Military Road; and

WHEREAS, Cleco Power LLC is to provide the work to provide its electric line in the servitude areas; and

WHEREAS, St. Tammany Parish Government has determined that it is in the public interest to enter into this Servitude Agreement; and

WHEREAS, a sketch defining the parcel on which the servitude is to be granted, as well as the proposed Servitude Agreement is attached hereto as Exhibit A; and

THE ST. TAMMANY PARISH COUNCIL HEREBY ORDAINS: that St. Tammany Parish Government, through the Office of the Parish President, is authorized to enter into a Servitude Agreement with Cleco Power, LLC for that certain property described on the attached Servitude Agreement and sketch for the purposes of providing a new 30' overhead electric line right of way across the parcel on N. Military Road; and

BE IT FURTHER ORDAINED: that the Office of the Parish President is authorized to exercise its discretion in granting a servitude on the property, together with all agreements and all transactions necessary to carry out the intent of this Ordinance; and

BE IT FURTHER ORDAINED: that any and all actions previously taken by the Office of the Parish President to grant a servitude on the property are ratified and accepted accordingly.

REPEAL: All Ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.
