ORDINANCE LEVYING MILLAGE RATES FOR THE GENERAL FUND FOR FISCAL YEAR 2026.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS that in a public meeting held on July 9, 2026, which meeting was conducted in accordance with the Open Meetings Law and the additional requirements of Article VII, Section 23(C) of the Louisiana Constitution and R.S. 47:1705(B), that the following **millage rates** are hereby levied upon the dollar of the assessed valuation of all property subject to ad valorem taxation within said Parish for the year 2026, for the purpose of raising revenue:

General Alimony is a millage authorized by the constitution of the state of Louisiana. This millage is critical to supporting the Parish General Fund, which is the only funding source for state-mandated costs of the public safety agencies.
