SECTION I: CAPITAL IMPROVEMENTS - INFRASTRUCTURE (ROADS, BRIDGES, DRAINAGE, AND UTILITIES)

Christmas Tree Habitat Restoration

Scope: Collect and reuse holiday trees to help restore and protect coastal marshes. Recycled trees reduce erosion, trap sediment, and create natural structures, which helps marsh vegetation grow back stronger.
