ORDINANCE TO AUTHORIZE ST. TAMMANY PARISH GOVERNMENT, THROUGH THE OFFICE OF THE PARISH PRESIDENT, TO RATIFY AND MAKE RETROACTIVE THE UTILITY SERVICES AGREEMENT FOR WATER AND SEWER SERVICES FOR LOVE’S TRAVEL STOPS & COUNTRY STORES, INC. (WARD 4, DISTRICT 11)

WHEREAS, St. Tammany Parish Government, through its Department of Utilities, seeks to ratify and make retroactive the Utility Services Agreement entered into with the developer of Love’s Travel Stops & Country Stores, Inc., to provide water and sewer treatment services to the large-scale fueling station, retail store and other amenities associated therewith; and

WHEREAS, the developer will install the water/sewer lines and related equipment needed to connect to Parish’s existing systems, at their expense and as more fully described in the Utility Services Agreement to be conected; and

WHEREAS, upon completion and acceptance of the water and sewer lines and related equipment, the developer shall donate said lines and equipment to Parish, as more fully described in the Utility Services Agreement to be conected.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that the Office of the Parish President is authorized to exercise its discretion in ratifying and making retroactive the Utility Services Agreement for provision of water and sewer services to Love’s Travel Stops & Country Stores, Inc., and to take all actions necessary, including entering into all agreements and all transactions necessary to carry out the intent of this Ordinance; and

BE IT FURTHER ORDAINED: that any and all actions previously taken by the Office of the Parish President in furtherance of the actions contemplated herein are ratified and accepted accordingly.

REPEAL: All Ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.

St. Tammany Parish Government seeks to enter into a Utility Services Agreement ("USA") for provision of water/sewer services to Love's Travel Stops & Country Stores, Inc. Appurtenant to the USA shall be the donation of lines constructed and/or extended and all related equipment necessary to facilitate such services. This will also include all necessary servitudes for future operation and maintenance by Dept. of Utilities.
