ORDINANCE TO AMEND THE 2024 CAPITAL IMPROVEMENT BUDGET AND CAPITAL ASSETS - AMENDMENT NO. 5  
PARISHWIDE ROADS & DRAINAGE CAPITAL PROJECTS

WHEREAS, St. Tammany Parish has prepared a capital improvement budget and capital asset list in accordance with the Home Rule Charter.

WHEREAS, the Parish has identified additional capital improvements, capital assets, and/or grant-funded improvements for Fiscal Year 2024.

**SECTION I: CAPITAL IMPROVEMENTS - INFRASTRUCTURE (ROADS, BRIDGES, DRAINAGE, AND UTILITIES)**

**CAPITAL PROJECTS - 200-4640 - PARISHWIDE ROADS & DRAINAGE**

Judge Tanner Blvd. Sidewalk

Scope: Installation of a 5 foot-wide sidewalk along Judge Tanner Blvd. from Holy Trinity Blvd. to Lakeview Dr.

Status: Project was selected as a recipient for funds under LADOTD's Safe Routes to Public Places program. SRTPPP has a \$500,000.00 maximum construction contribution. The Parish is responsible for costs exceeding the \$500,000.00 maximum plus a 20% contingency.

Pedestrian/Bicycle Master Plan

Scope: The proposed project consists of the preparation of the St. Tammany Parish Comprehensive Pedestrian and Bicycle Plan (CPBP) to address existing deficiencies and to assess further expansion of walking and bicycling infrastructure to make the Parish a safer place for these activities.

Status: Project scope is currently under review by LADOTD. Once approved, NORPC will begin the process to hire a consultant.
