-Rolling - 1. Review of Parish Council Agenda for the regular meeting on February 08, 2024. (Meeting Agenda available in Council Office or on Parish website: www.stpgov.org)

APPOINTMENTS

- -Phillips asked about staggering of terms for appointment #2, "Resolution to reappoint three (3) members whose terms have expired and to appoint two (2) members to fill vacancies on the Board of Commissioners for St. Tammany Parish Sub-Drainage District No. 2. (Phillips)".
- -Emily Couvillion responded that this board does not have staggered terms.
- -Binder asked if there were resumes for appointment #5, "Resolution to appoint nine (9) members to fill regular seats of which terms have expired and two (2) members to fill alternate seats on the Board of Commissioners for the Planning and Zoning Commission. (Parishwide) (Laughlin)".
- -Council staff confirmed that there are resumes available.
- -Laughlin asked about staggered terms for appointments moving forward.
- -Couvillion explained the plan moving forward regarding staggering of terms.
- -Impastato clarified a that appointment #7 should say nominate and not appoint, "Resolution to appoint Earl B. Gorrondona to replace David Lindsey (term expired) on the Board of Commissioners for Fire Protection District No. 4. (Impastato)".
- -Phillips asked about mentioning names on appointment items.
- -Couvillion gave clarity regarding nominating.
- -Cougle asked about staggering of terms and why wait.
- -Couvillion explained waiting until terms expired.
- -Parish President asked about terms running concurrent.
- -Covuillion explained that it depends on which board it is.

- -Terry Hand asked about other boards not complying when they have other members that are appointed by municipalities.
- -Couvillion responded.
- -Impastato moved to refer appointments #1 through #7 to the full Council, seconded by Corbin. Unanimous with no one absent.
- -Rolling mentioned pulling items #1 and #2 under Ordinances for Introduction.

Tanner – moved to refer Ordinances for Introduction #1 and #2 to the Finance committee, along with #11 through #18, seconded by O'Brien. Unanimous with no one absent.

-Rolling went through each category of the agenda, asking for any items that Council, Administration, and public wished to pull.

ORDINANCES FOR INTRODUCTION

- **4. Ordinance Calendar No. 7489** Ordinance accepting Oak Alley Meadows Ph. 1 into the Parish Maintenance System. (Ward 3, District 3) (Cazaubon/Cooper)
- -Cazaubon asked Jay Watson a question about phases in this subdivision.
- -Watson and Daniel Hill responded to her questions.
- -Cazaubon moved to refer to the full Council, seconded by Tanner. Unanimous with no one absent.
- **10. Ordinance Calendar No. 7495** Ordinance to declare a tax-adjudicated property as surplus property and to authorize the parish to proceed with the process for advertising the sale of such adjudicated property. (Phillips/Cooper)
- -Phillips asked for explanation of this ordinance.
- -Couvillion explained that this was to declare property as surplus.

RESOLUTIONS

- -Tanner asked to pull #1, #7, and #8 for discussion.
- -Rolling mentioned also pulling #5.
- Resolution Council Series No. C-6860 Resolution to conclude the Investigation and Review, including corrective actions taken to prevent similar issues in the future, originally convened by Resolution Council Series No. C-6775 on June 01, 2023, into the manner in which the proposed Covington Trace Ridge Apartments development has been processed. (Dean) (Postponed 12/18/2023) (Postponed 01/11/2024)
- -Tanner said there are a couple of copies of this resolution that are passed around and she would like to see the one that is going to be voted on.
- -Couvillion explained that #1 has been postponed several times and should be the same.
- -Tanner asked Rolling how he was planning to handle this resolution.
- -Rolling responded that they would discuss at the Council meeting.
- -Tanner moved to refer to the full Council, seconded by Impastato. Unanimous with no one absent.
- 5. Resolution Council Series No. C-6878 Resolution to concur/not concur (circle one) with the City of Slidell annexation and rezoning of Lot 3A, SQ 9 Lindberg Glen S/D, from Parish HC-2 (Highway Commercial) to City of Slidell C-4 (Highway Commercial). Property is located near intersection of interstate 10 and Robert Road, Slidell, LA, situated in Section 41, Township 8 South, Range 14 East. (Ward 8, District 13) (Corbin/Cooper)
- -Clerk explained the error in the title of this resolution.
- -Couvillion explained to Corbin that he would need to pull this at the Council meeting to concur or not concur with the annexation. She also explained that this can just be something that is corrected at the meeting next week.

- -Corbin moved to refer to the full Council, seconded by O'Brien. Unanimous with no one absent.
- **7. Resolution Council Series No. C-6880** Resolution requesting outside counsel to withdraw from certain current State and Federal pending litigation against St. Tammany Parish Government and Parish Council. (Impastato)
- -Tanner said Lagarde is in attendance and he would like to withdraw. She would like to amend to take the term terminate off and make sure he is paid for his time.
- -Ross Lagarde will email everyone and explain his concerns. Said there was a different resolution drafted that led to some confusion. Will gladly withdraw and deal with payment information in the future.
- -Tanner asked if she had the right resolution.
- -Clerk responded if she got it from the website then, yes, she did.
- -Tanner refer to full Council, seconded by Impastato. Unanimous with no one absent.
- **8. Resolution Council Series No. C-6881** Resolution consenting to the waiver of conflict by the current Parish Council and its members which may exist regarding the legal representation of the District Attorney in certain State and Federal litigation. (Impastato)
- -Tanner has concerns again about the wording. Doesn't know what rights Council is giving up with this resolution. Not exactly sure what this means. Asked how does this affect the Council.
- -Couvillion DA office would advise Council to seek independent 3rd party Counsel to address those issues.
- -Tanner said she is still confused and asked Lagarde to help her with this.
- -Lagarde confirmed what Couvillion said and said he has not spoken with anyone regarding this, but said he would speak with her at another time. He did not want to address it at the meeting to keep the attorney/client privilege.
- -Tanner moved to refer to the full Council, seconded by Corbin. Unanimous with no one absent.
- -O'Brien moved to refer the remainder of the items on the Consent Calendar to the full Council, seconded by Tanner. Unanimous with no one absent.

ORDINANCES FOR ADOPTION

- -Tanner moved to refer Ordinances for Adoption #13 through #21 to the Finance committee, seconded by O'Brien. Unanimous with no one absent.
- -Impastato moved to refer the remainder of the Ordinances for Adoption to the full Council, seconded by Corbin. Unanimous with no one absent.

EMERGENCY ORDINANCE

- 1. Ordinance Calendar No. 7507 Emergency ordinance to impose a thirty (30) day moratorium on the issuance of permits for construction or placement of building structures on any properties within the Forest Glen Subdivision located in Council District 7. (Impastato)
- -Impastato moved to refer to the full Council, seconded by Tanner. Unanimous with no one absent.
- -Binder explained that both appeals are in his district and he has done his due diligence. He said he would be prepared to move on them.
- -Terri Lewis Stevens made comments about public comments and the speaker cards.
- -There being no further business, meeting adjourned at the call of the Committee Chairman.
