Administrative Comment Amendment No. 5 - 2024 Operating Budget - March 2024

This budget amendment is to:

a. 101 - DRAINAGE MAINTENANCE FUND

FUNDING SOURCE: AD VALOREM TAXES

To amend the budget for Amendment 5 between St. Tammany Parish Government and the St. Tammany Levee, Drainage, and Conservation District which extended the term for 5 years to November 5, 2028 and added \$200,000 for a total of \$300,000 to support the District to ensure that certain operations related to the statutory duties of the District are carried out.
