RESOLUTION TO VACATE, IN PART, THE MORATORIUM ORIGINALLY ESTABLISHED BY ORDINANCE COUNCIL SERIES NO. 19-4114 ON THE ISSUANCE OF BUILDING OR CONDITIONAL USE PERMITS FOR CONSTRUCTION OR PLACEMENT OF BUILDING STRUCTURES ON PROPERTY WITHIN A PORTION OF UNINCORPORATED TOWN OF ALTON SUBDIVISION, SPECIFICALLY LOTS 3 AND 12 OF SQUARE 61, ALTON, ST. TAMMANY PARISH, LOUISIANA ALSO BEARING THE MUNICIPAL ADDRESS OF 61534 NORTH 8TH ST., SLIDELL, LA 70460. (WARD 9, DISTRICT 14)

WHEREAS, on August 09, 2019, the Parish Council adopted Ordinance Council Series No. 19-4114 establishing a six (6) month moratorium, and subsequently adopted Ordinance Council Series Nos. 20-4222, 20-4365, 21-4502, 21-4659, 22-4801, 22-4971, 23-5088, 23-5254, 24-5399, 24-5481, 24-5639, 25-5764, and 25-5867 on the re-subdivision and/or issuance of permits for construction or placement of building structures on property within a portion of unincorporated Town of Alton Subdivision; and

WHEREAS, to protect and preserve the health, safety and property interests of residents from the adverse effects of traffic and flooding hazards resulting from intensification of development within a certain portion of unincorporated Ward 9, District 14 of St. Tammany Parish, a temporary moratorium is necessary to allow sufficient time for review of existing land uses and to formulate measures to protect residents in and near the area; and

WHEREAS, it has been requested that the moratorium be lifted on Lots 3 and 12 of Square 61, Alton Subdivision, also bearing the municipal address of 61534 North 8th St., Slidell, LA 70460; and

WHEREAS, it has been determined that the lifting of the moratorium on the above-mentioned property would not contribute to the adverse effects of traffic and flooding hazards.

THE PARISH OF ST. TAMMANY HEREBY RESOLVES that pursuant to Chapter 2, Article XVI, Sec 2-264 of the Code of Ordinances, the Parish Council vacates, in part, the moratorium established by Ordinance Council Series No. 19-4114, and any subsequent extension thereof, to remove therefrom the restriction on the issuance of permits for construction or placement of building structures on Lots 3 and 12 of Square 61, Alton Subdivision, also bearing the municipal address of 61534 North 8th St., Slidell, LA 70460
