AN ORDINANCE TO OFFICIALLY NAME THE 30-FOOT RIGHT-OF-WAY IDENTIFIED ON THE ATTACHED SURVEY LONG SHADOW LANE (WARD 5 DISTRICT 6).

WHEREAS, a petition has been submitted to the Department of Planning & Development and forwarded to the Parish 911 Communications District signed by at least 50 percent plus one of the property owners owning or fronting the 30-foot right-of-way has been submitted; and

WHEREAS, the St. Tammany Parish 911 Communications District has received, reviewed and approved the Road Name Request Form for the unnamed 30-foot right-of-way. Pending Approved Name: Long Shadow Lane, Nearest Cross-street: Highway 1082, Bush, LA 70431. Since future structures will be addressed off the newly named 30-foot right-of-way; the access will be added to the 911 Database and to the 911 Dispatch Map;

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that St. Tammany Parish Government officially name the 30-foot right-of-way shown on the attached survey as Long Shadow Lane.

REPEAL: ALL ordinances or part of ordinances herewith are hereby repealed.

SEVERABILITY: if any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.
