Bon Temps Sewer System

Scope: The project will require engineering, construction, and supplemental services for the Bon Temps sewer collection and conveyance system relocation and rehabilitation. The existing Bon Temps lift station is deteriorating and in need of complete replacement. It is currently located in the grounds of Franco's Health Club and Spa, together with its sewer collection piping and equipment. As part of this project, a new, relocated duplex sewer station will be constructed. All sewer collection lines will be rerouted to this new facility, and the existing lines will be plugged and abandoned in place.
