Scope: The project will address the traffic flow on campus including traffic control, road conditions, and parking. The purpose of the project is to analyze the needs of the campus, design the plan with phases, and to construct the first phase. The project will include traffic studies, road evaluations, improving existing parking, adding new parking spaces, and placement of dumpsters.

Status: Once approved, the estimated time for completion for design and Phase 1 construction will be 12 - 18 months.
